General Meeting May

- Financial report 2008 approved
- Dmitry Burkov re-elected for another 3-year term
- Discussions:
 - Charging scheme 2010: 2007-01 (Direct Assignments to End Users) and its implications on the charging scheme
 - Voting Options: improving accessibility, simplifying the procedure, but no significant changes (like e-voting)



Ongoing Preparations for the Future

- Following Strategy Workshops with Executive Board
- Working on three main areas of attention
 - Role of the RIPE NCC: Community Building, Outreach, PR
 - Trusted Source of Data: Hardening Registry, Reporting Tools
 - Number Resource Lifecycle Management: Allocation, Auditing, Reclamation, Certification
- Developing and adjusting priorities accordingly
 - Deriving operational priorities from strategic outlook

Certification in the RIPE Region

- Developing with Input from Community
 - RIPE Certification Task Force
- Have announced limited testrun at RIPE 57
 - Several dozen participants
- Next steps
 - Potential issues were presented at RIPE 58
 - Consensus to continue work
- Coordinating with other RIRs
 - Interoperability
 - Processes
 - Policies



Policy Development

- 2007-01 "Direct Internet Resource Assignments to End Users from the RIPE NCC"
- Contracts with LIRs needed
 - Last resort with RIPE NCC directly
- Implementation Phase 2 starts in May 2009
- 2006-01 "Provider Independent (PI) IPv6
 Assignments for End User Organisations"
- Implemented May 2009
- 2007-08 "Enabling Methods for Reallocation of IPv4 Resources" (a.k.a. Transfer proposal)
- Implemented January 2009

- 2008-05 "Anycasting Assignments for TLDs and Tier 0/1 ENUM"
- 2009-02 "Allocation/Assigning Resources to the RIPE NCC"
- 2008-08 "Initial Certification Policy for Provider Aggregatable Address Space Holders"
- 2009-05 "Multiple IPv6 /32 Allocations for LIRs"





Information Services

- Significant overhaul of the IS portal focusing on
 - Needs of different user groups
 - Integrated tools and applications
 - Intuitive and attractive user interface
- Interviews with representatives of user groups during RIPE58
- Increased cooperation with other RIRs
 - APNIC: extending active measurements in the AP
 - LACNIC and AfriNIC new measurement nodes in Montevideo and Johannesburg.



DNS Activities

- Reviewing DNS infrastructure
 - Hardware
 - Processes
 - DNSSEC provisioning system
- Replacing complete hardware of several K-root instances
- Cooperation with AfriNIC
 - AfriNIC's Anycast Project
 - New K-root instances in Africa
 - A "lite" version of the cluster
